

Welcome to Gateway Technical College's Background Check Request system.


1. Click on the appropriate box to select the Background Check option you need. The base CBC price is \$27.






- Read the Price Information carefully. Your final price is determined by the number of prior names (aliases), previous addresses, and states other than Wisconsin.


