Dear Mr. Whyte:

As you are aware, we received construction bids for the Boiler Plant Upgrade project on behalf of Gateway Technical College on Friday, June 28, 2013 at the Administration Center on the Kenosha Campus with Judy Braun and John Thielen in attendance on behalf of Gateway, as well as myself present on behalf of Partners in Design Architects.

The Boiler Plant Upgrade project was bid as a single base bid package with two alternate bids as follows:

- Base Bid Boiler Plant Upgrade including architectural, HVAC and electrical scope
- Alternate Bid No. 1 To install new DDC control package on existing air handling units
- Alternate Bid No. 1A To install new DDC control package on existing VAV boxes

Having reviewed bids with Mr. Thielen and yourself, Gateway has decided to award the Base Bid Package and both Alternates No. 1 and No. 1A to Lee Heating and Cooling, Inc. We are recommending that the College enter into a contract with Lee Heating and Cooling, Inc. to complete the Racine Campus Boiler Plant Upgrade, inclusive of both alternate bids.

Based on our bid evaluation, we further recommend that the contract value for Lee Heating and Cooling, Inc. be \$652,170.00. Gateway should also budget approximately \$57,064.00 for architectural and engineering fees as well as budget \$500.00 for reimbursable costs related to the competitive bid process and various approvals.
