#### Overview

The purpose of this articulation agreement is to provide a seamless transfer process for Gateway Technical College (Gateway) students who desire to further their education by attending the University of Wisconsin-Parkside (UW-P). Through the collaborative efforts of faculty, student services, and administration, students will encounter a clear path to reach their educational goals. Gateway Technical College students who successfully complete the Associate of Applied Sciences Degree Physical Therapist Assistant-10-524-1 and who meet the admission requirements of UW-P and any other conditions specified in this agreement will be admitted to the UW-P Bachelor of Science with a major in Applied Health Sciences-Pre-Physical Therapy or Pre-Athletic Training concentration. Gateway Technical College and UW-P will cooperate in the delivery of courses and the transfer of credits to help meet the post secondary educational needs of the population of Wisconsin.

## Terms and Conditions of the Articulation Agreement

The terms of this agreement apply only for the purposes of entry to the Applied Health Sciences major and the - Pre-Physical Therapy or Pre-Athletic Training concentration at UW-P by Gateway Technical College students who have completed the following terms and conditions.

**Admission.** It is the student's responsibility to demonstrate fulfillment of the current admission requirements of UW-P at the time of entry into UW-P. Gateway Technical College students will be admitted to the UW-P Applied Health Sciences major and the Pre-Physical Therapy or Pre-Athletic Training concentration once they successfully completed the following:

1: Completion of the Associate of Applied Sciences Degree in Physical Therapist Assistant-10-524-1 and the following

UW-P courses: BIOS 105, BIOS 106, BIOS 101, BIOS 102 (see table). These four UW-P courses will be taken while enrolled in the AAS degree at Gateway Technical College. Students will concurrently enroll as non-degree students at UW-P to complete and transfer back credit for these UW-P courses to the AAS program. These UW-P courses (which are core course for the BS degree) will, upon transfer, fulfill requirements toward the BS degree with a major in AHS at UW-P.

- 2: Graduating grade point average of 2.5 or higher.
- 3: Fulfillment of the current UW-P admission requirements at the time of application.
- 4: Gateway Technical College students are required to declare the major of Applied Health Sciences Pre-Physical Therapy **or** Applied Health Sciences-Pre-Athletic Training once admitted to UW-P.

Advising. Gateway Technical College will provide academic advising to their students to make them aware of this articulation agreement, the conditions the students are required to follow and the courses they need to complete in order to successfully transfer to UW-P. UW-P will provide academic advising to Gateway Technical College students pre and post admission to the UW-P. UW-P will provide materials, catalogs, and other information to the appropriate Gateway Technical College Academic Advisors to facilitate their understanding of requirements and programs. Gateway Technical College will assist UW-P in arranging recruitment events on its campuses.

**Tracking.** Gateway Technical College will provide UW-P admission office the names of students following the articulation agreement and who intend to transfer to UW-P. This will allow UW-P to plan for the admission, advising and orientation of these transfer students. UW-P will send Gateway Technical College the total number of credits transferred from Gateway annually or other data that can be conveniently produced.

**UW-P Graduation Requirements.** All graduation requirements need to be completed in order to graduate from UW-P. Students need to complete the requirements of the B. S. degree with a major in Applied Health Sciences with a concentration of Pre-Physical Therapy or Pre-Athletic Training, general university requirements and any other degree requirements that are needed to receive a bachelor's degree at UW-P. These requirements can be found in the UW-P catalog. Please note, students are subject to the major requirements in force in the catalog at the time they are first accepted in a particular major.

Courses included in agreement. In the event that the course curricula and/or academic program of either institution undergo significant revision or change it is the responsibility of that partner institution to inform the other partner institution of the change/s within 120 days of the change. UW-P will review any additional courses submitted by Gateway Technical College for transfer toward fulfilling agreement requirements. In turn, Gateway Technical College will review additional course suggestions submitted by UW-P that will fulfill agreement requirements.

**Periodic Review.** This agreement will commence upon execution by UW-P and Gateway Technical College and shall expire two years after that date. This agreement shall automatically be renewed for additional successive two year periods unless a party terminates the memorandum by providing notice to the other in

writing on or before one hundred and eighty (180) days prior to expiration of the original term or any renewal term. Both parties will meet on an annual basis to discuss any issues, major or minor, that may arise within the governance of this agreement.

Marketing. Any marketing of this agreement will be subject to the prior approval of both parties and will adhere to each institution's standards for the use of its name and logo. Each institution will assume responsibility for appropriate marketing to reach its student population. Each institution may provide a link to this agreement and/or the other institution at its website, with notice to the other party.

**Accreditation**. Both parties agree that failure to maintain regional accreditation will be grounds for termination of the agreement.

**Cancellation**. Both parties agree to provide at least 180 days advance written notification of their intent to cancel this agreement. Gateway Technical College students who apply to UW-P prior to the cancellation date will be permitted to transfer credits under the agreement terms.

**Proficiency and Transfer courses.** Courses marked as proficiency or transfer from another institution on a Gateway Technical College transcript will be accepted at the discretion of UW-P. Students will be required to supply an original transcript from the originating institution for courses transferred to Gateway Technical College and may be required to provide syllabi for some courses.

**Oversight of the Agreement.** The Provost office at UW-P, representing faculty and staff, will provide oversight of the agreement jointly with the Provost office at Gateway Technical College.

## **B.** Skills Requirements:

Completion of A. A. S. in Physical Therapist Assistant (10-524-1) degree fulfills the Reading and Writing skills and the Computational skills requirement via the following courses: 801-136 English Comp. 1 (UW-P ENGL 101) and 804-115 College Tech. Math 1 (UWP MATH 112).

## C. Information Literacy:

Students need to complete this requirement upon admission to UW-P

## D. Foreign Language Requirement:

Gateway Technical College students need to meet the following UW-P foreign language requirement.

The foreign language requirement can be met under any of the following circumstances.

- Students who completed a minimum of two years of one second language at a secondary school with a final grade of C or better (grade of C-minus is not acceptable) in the last course taken.
- Students who completed one high school unit and one college semester in the same language, provided that the college course is at least on the second-semester level.
- Students who are heritage speakers in a language taught at UW-Parkside or who have informally learned a language taught at UW-Parkside can meet the foreign language requirement if they take the

UW System placement test and place into the equivalent of the third semester (intermediate level) or above.

- Students who are heritage speakers in a language not taught at UW-Parkside or who have informally learned a language not taught at UW-Parkside can meet the foreign language requirement upon certification at the intermediate level through the American Council on the Teaching of Foreign Languages (ACTFL).
- Students who have graduated from a foreign secondary school with a curriculum taught in the language native to that country, other than English, will be considered to have met the foreign language requirement.
- International students from countries where English is not the primary language are considered to have met the foreign language requirement when they meet the required standard of English competency at the time of admission through the appropriate Test of English as a Foreign Language (TOEFL) score.

## **Placement Tests for Foreign Language Courses**

UW-Parkside uses the UW System Foreign Language Placement Tests in French, German, and Spanish to place students into the appropriate course level of their selected foreign language. Tests are administered throughout the year; specific testing dates and information are available at the Learning Assistance Department. Students who place into language courses numbered 104 (beginning level 2) or 204 (intermediate level 4) are advised to audit 103 or 203, respectively, in the fall and then take 104 or 204 in the spring. Students cannot begin language study (103 or 203) during the spring semester.

## Retroactive Credits in Foreign Language

The Modern Language Placement Test is required for any UW-Parkside student who wishes to receive college credit for language competency reached in high school. Students may earn up to 16 retroactive credits, four for each of the first four semesters of language study, if: a) they completed the previous course work in a United States high school, b) they enroll in the college course into which they place, and c) they complete the course with a grade of B-minus or better. In order to be granted retroactive credit, the student must submit an application to the Advising Center at the end of the appropriate college semester.

## Retroactive Credit in Foreign Language for Transfer Students

UW-Parkside will accept retroactive credit for foreign language if it was granted by another UW System institution and is documented on the student's UW System transcript. Students or advisers with questions about an individual situation should contact the chair of the Modern Languages Department. Advanced students in a foreign language should consult with an adviser in the Modern Languages Department.
